I am directed to say that the Governor of Assam is pleased to convey the sanction of an amount of ₹ 61.12 lakh (Rupees sixty one lakh twelve thousand) only as state share as grants in aid relating to the year 2010-11 (on 5500 : 500 basis 4th, 5th 3rd & 7th and final installments) for implementation of the schemes under IWDP / Hariyali programme / project during 2010-11 in pursuance to the sanction and release by the Govt. of India's sanction letter with the following conditions :-

- (3) The works should be taken up only after observing all formalities as per Rules/Procedures before implementation of the Scheme.
