I am directed to say that the Governor of Assam is pleased to convey the sanction of an amount of ₹ 1901.30 lakh (Rupees one thousand nine hundred one lakh thirty thousand) only being the state share of 2nd instalment on 90:10 basis as grants in aid for implementation of the scheme under MGNREGA relating to the year 2010-11 in pursuance to the sanction and release by the Govt. of India's sanction letter with the following conditions :-

- (1) The terms and conditions should be strictly adhered to in terms of Govt. of India's guidelines.

- (3) The works should be taken up only after observing all formalities as per Rules/Procedures before implementation of the Scheme.
