NOTIFICATION

No. RDD 136/2008/262: In partial modification of this Department's Notification No. RDD 136/2008/212 dtd. 27/8/2010, the Governor of Assam is pleased to notify the Chief Executive Officer of the Zilla Parishad as the Nodal Officer for all schemes of National Social Assistance Programme (NSAP) at the district level in the general areas of the State of Assam and Project Director, DRDA of the districts under Bodoland Territorial Council and for Karbi Anglong Autonomous Council as the Nodal Officer for all schemes of NSAP at the district level in the areas under Bodoland Territorial Council and Karbi Anglong Autonomous Council. The notification issued vide No. RDD 414/2003/118, dtd. 29th August 2006 (copy enclosed) for Constitution of District Level Committee stands in supersession of all other earlier notification issued for the purpose. However functions of the Committee, which would sit atleast once in a quarter, would pertain to monitoring and evaluation of the NSAP Scheme only. Selection procedure for beneficiaries would be as per guidelines issued vide letter No. RDD 136/2008/215 dtd. 9th Sept' 2010.

2. Governor of Assam is further pleased to direct that all the Official works on execution of NSAP will be performed by the Chief Executive Officers of Zilla Parishad in the districts under the general guidance and supervision of the Deputy Commissioner who is the drawing and disbursing Officer of NSAP and by the Project Director, DRDA in the areas under Bodoland Territorial Council and Karbi Anglong Autonomous Council under the general guidance and supervision of the Principal Secretary of Bodoland Territorial Council / Principal Secretary, Karbi Anglong Autonomous Council. The Chief Executive Officer of Zilla Parishad in the general areas and the PD, DRDA in the districts under Bodoland Territorial Council and Karbi Anglong Autonomous Council will ensure proper and timely implementation of the schemes together with entry of data base and submission of Monthly Progress Report, uploading of data etc in the NSAP website timely to the concerned authorities. A copy of all records of implementation since the transfer of these schemes to P&RD since June 2003 if not available with the Chief Executive Officer / Project Director, DRDAs (Bodoland Territorial Council and Karbi Anglong Autonomous Council) shall be obtained by the Chief Executive Officer, Zilla Parishad / Project Directors (Bodoland Territorial Council and Karbi Anglong Autonomous Council) concerned for his / her record.
