AFTER EXAMINING THE DISTRICT PLANNING COMMITTEE FORMED BY DIFFERENT DEPUTY COMMISSIONER FOR THE YEAR 2010-11 AS PER PROVISION OF SEC 3 OF THE ASSAM PANCHAYAT ACT 1994 OBSERVE THAT BESIDES THE MLAS (COMMA) MPS (COMMA) CHAIRMAN ZILLA PARISHAD AND CHAIRMAN OF THE HEAD QUARTER MUNICIPALITY WHICH CONSTITUTES ONE FIFTH OF THE DPC AND PERMANENT MEMBERS (COMMA) ALL THE ELECTED MEMBERS OF THE ZILLA PARISHAD AND MOST OF THE ANCHALIK PANCHAYAT PRESIDENT AS MEMBERS ARE INCLUDED IN THE DPC (.)
